

DECEMBER 2021 – etfSA.co.za MONTHLY SOUTH AFRICAN ETF, ETN AND UNIT TRUST INDEX TRACKING PERFORMANCE SURVEY

The Monthly Index Tracking Performance Survey for the period ended 31 December 2021, is attached.

3-10 Years

Global index tracking ETFs, referencing equity or commodity indices, continue to dominate the longer-term performance data.

However, the strong commodity cycle between 2016-2021, which pushed precious metals and some other commodity prices to the fore, now appears to have abated. World economic recovery, post COVID-19, plus the recovery in global automobile production, should continue to help certain metals that can be purchased on the JSE, in ETF form, such as platinum group metals, but the commodity cycle may now be reaching a more mature stage and the future pace of price increases might be more muted.

1-3 Years

For the one to three year period, investment in high tech referenced ETFs and index tracking unit trusts, has been lucrative. More recently, index trackers that reference global property markets, have rebounded strongly, even more so than local listed property ETFs and unit trusts. The commercial property industry seems to be coming to terms with the COVID pandemic and specialist property developments that are specifically tailored to changing work practices and practice "green" principles, are being priced at premiums.

3 - 6 Months

For the period 6 months or less, it is of interest that some 1nvest "factor" unit trusts are showing top investment returns.

These are "smart beta" products that select shares to be included in an index based on factor considerations, value and momentum are the current best performing factors, covered by these 1nvest index tracking unit trusts. It may be that the less rigorous tracking and reporting requirements of unit trusts, rather than listed ETFs and ETNs, provide greater flexibility in managing smart portfolios and the longer term investment performance of these products will be of interest.
