The Monthly Index Tracking Performance Survey for the period ended 31 January 2021, is attached.

3-10 Years

Foreign referenced ETFs continue to dominate for the longer term periods covered in the Survey, with the Sygnia Itrix ETFs, covering major equity markets, providing many of the top total returns for 5 and 10 years. The 5 year data also shows the incredible annual returns provided by PGM metal ETFs.

1-3 Years

The one to three year statistics, show a shift from global assets, both equities and commodities, giving the best returns over 3 years, to South African based ETFs and index tracking unit trusts providing the best investment returns over one year.

3 - 6 Months

The very recent drop in global equity markets, particularly the high tech sectors, has been further reflected in two areas of investment, namely Platinum Group Metals and South African equity indices staying at the fore. The commodity price recovery may be attributed to supply disruptions arising from the Russian situation.

The superior returns shown by local assets may, however, have further legs, as many South African companies continue to announce great earnings.

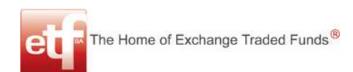
