

JULY 2022 – etfSA.co.za MONTHLY SOUTH AFRICAN ETF, ETN AND UNIT TRUST INDEX TRACKING <u>PERFORMANCE SURVEY</u>

The Monthly Index Tracking Performance Survey for the period ended 29 July 2022, is attached.

The Monthly Performance Survey shows a reversal of the short-term trends.

Foreign referenced ETFs are now performing better than the local (SA) market. Leading the way are some of the new listings of ETFs on the JSE that give exposure to smart beta or thematic indices. Examples are the FNB index tracking ETNs, referencing global clean energy and the S&P 500 low volatility indices and the Sygnia Itrix Healthcare ETF.

The broader market indices, like the S&P 500 US index trackers have also rebounded in the past three months, with the Satrix Nasdaq 100 ETF leading the way.

Good earnings growth by major US and other global companies appears to be the key positive variable. However, concerns remain about the duration of the current supply-side driven inflation, the extent of monetary tightening by the major central banks and if the global economy sis facing a soft, or hard landing.

Of interest is the variety of ETFs/ETNs now listed on the JSE which give exposure to various asset classes, risks and styles – all of which need to be monitored carefully to derive maximum main performance benefits. For investors without the time to undertake such rigorous examination of the choices, the major S&P, World and other broad market indices are all showing signs of recovery. Whether major equity markets have bottomed or not is not immediately clear, but not being in the market can be detrimental to investors.
