

JUNE 2021 – etfSA.co.za MONTHLY SOUTH AFRICAN ETF, ETN AND UNIT TRUST INDEX TRACKING <u>PERFORMANCE SURVEY</u>

The Monthly Index Tracking Performance Survey for the period ended 30 June 2021, is attached.

With one year total returns of 22,89% for the FTSE/JSE Top 40 index (25,07% for the All Share index), versus 12,80% for the MSCI World index (in rands) for the past 12 months, the Performance Survey now generally features better 1 year returns for SA referenced ETFs. This is first time for over a decade that rand hedge offshore assets have not provided generally higher average short-term total investment returns rather than local assets.

However, a stand-out feature in the very short-term investment returns (3-6 months), are the single stock ETNs issued by FNB that allow access to many top individual shares listed on US exchanges at low cost and with zero foreign exchange restrictions. Judicious selection of such ETNs have provided very good rewards over the past six months.


